## AGREEMENT FOR CONTINUATION OF WAREHOUSE LEASE

This Agreement Continuation ("Agreement") is made and entered into on this **Thirteenth Day of June, 2025**  
BETWEEN:

AND

**Rukmani Devi Garg Agro Impex Limited** (formerly known as Rukmani Devi Garg Agro Impex Private Limited), a company duly incorporated bearing CIN U24246RJ1998PLC014771 having registered office at Plot N. 7 Bhamashah Mandi Anantpura Kota Rajasthan. Rajasthan, 324005, having email id rukmanidevigarg@gmail.com through its director Vishal Garg (*hereinafter referred to as "Lessee" which expression unless repugnant to the context shall include its successors and assigns*) of the second part.

WHEREAS:

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:


